Provincial's letter

Dear Confreres

I have just arrived back from attending the Council of the Society (CS13) in Dublin. I consider it a great privilege to have attended this meeting on behalf of the Province.

A great meeting

While I have very little experience in being part of gatherings at this level, like most of you, I have attended so many workshops, assemblies, and the like, I can be quite critical of the whole business and very hard to please when it come to meetings. CS13, however, was a great meeting and I am truly delighted to have been a part of it.

The meeting was well planned. The hosting region of Ireland could not have been more hospitable or helpful. The conference centre where we stayed (Emmaus) was modern, well appointed, and very comfortable. Catering at the centre was excellent. Our meeting facilitators, Mick Mullins and John Honner, did a superb job.

However, in my view, the mix of the participants and the matter of the Council may have been the elements that made the meeting so successful.

Never on a big issue

In meetings like CS13 it is common to get opposition and resistances surfacing in many quarters and on many questions which prevent a group from being able to gel and arrive at a successful outcome.

I would estimate that, on a few occasions, we had at most $1-1\frac{1}{2}$ fellows in the group who held contrary views to the rest. On these rare moments when differences arose it was never on a big issue which threatened to destabilise the meeting. This is not saying that good discussion and differing points of view were not part of the meeting. There was plenty of good constructive debate. It was the experience of our facilitators that guided us and helped us to keep moving forward.

Critical to the SM and its future

Probably the main work of CS13 focused around the Reviews of Governance and Finances within the Society. Both Reviews were asked for at the last General Chapter and over the last three years especially have been seriously pursued by the GA. We are probably more aware of the governance review because we were all invited to take part in it on a couple of occasions at regional meetings, but it is good to keep in mind that both reviews are critical to the Society and its future.

Some will look at the two finalized documents to come from the reviews and express disappointment that they don't clearly see on the

horizon major changes in the Society described in detail. What CS13 delegates approved in both reviews were a series of goals and then a number of recommendations or strategies.

No toothless tiger

Don't be misled and feel that these recommendations are very innocent and no more than a toothless tiger. They are very significant and will enable the Superior General and the GC to make really big calls and bring about substantial changes when these are needed. Over the next four years some major things will be foreshadowed out of these reports which will be for the next General Chapter to implement in 2017.

CS13 recognised a number of times that governance of the Society, with its annual meeting of the Superior General, his GA, and the major Superiors, now gathering for an annual meeting (ARC) in Rome, is much more collegial in leadership, animation, and management of the Society than it was in the past. This important modern feature of the Society will only get stronger.

Apart from dealing with the Governance and Finance Reviews many



other vital issues came before CS13 a number of times. Because of space I will not go into them here. Later "official" reports will inform us about how issues such as laity, formation and ministries developed and emerged from the process of CS13. Except if you are of a really cynical bent I am confident that they will excite you very much.

Assistants General

One significant thing to come from of CS13 was the re-election of the same General Council for the next four years: Frs. Larry Duffy (VG), Kevin Duffy, Lote Raiwalui, and Alejandro Muñoz. The General, Fr John Hannan, has flagged that they may be the same team but they may not necessarily be in the same position and doing the same things in the future.

I hope all have had a chance to see the 1 page communiqué, "Statement of Commitment", that the CS issued last week. Some confreres will dismiss it as being "too much like a motherhood" sentiment. That is a pity. This statement must be read and prayed over. It is telling us what the Society's leadership wants of each one of us.

To make a big impact

We are a "small" congregation, which each day is getting smaller in number, but is still able to make a big impact. This will only happen if we are more focussed, more overtly Marist, more international, more collegial, working more closely with the laity and are more courageous. CS13 were really convinced of this.

If any of us are not prepared to be a fair dinkum Marist, part of the team and committed to live as CS calls us, then we must move aside because we are blocking the Society which wants to move ahead. For my part, I will be putting my energy into supporting those who really want to follow the call of CS13 and allow our "small" Society to make an impact.

Tony Biddle: Congratulations to Tony, who is about to be made a Knight of the Order of St Sylvester for his distinguished services to the Church in the archdiocese of Sydney. The investiture will take place at Cathedral House on Wed, Nov 13: Garry Reynolds, Bob Barber, and Peter McMurrich will represent the province and hopefully bring back some photos. The honour is richly deserved, and will coincide with the conclusion of many years of dedicated and extremely competent service by Tony, most recently as province manager, and before that as business manager at CTU. The day after the investiture, the new papal knight will be feted by confreres, friends, and supporters at a special morning tea at Hunters Hill.

For those interested in the medal worn by Knights of St Sylvester, our research team came up with the following: *The current decoration or* cross of the Order is a gold cross of white enamelled surface, in the centre of which is impressed the image of St. Sylvester, surrounded by a blue enamelled circle bearing the inscription in letters of gold SANC. SYLVEST-ER P. M. On the obverse, in the centre, are the Papal tiara and crossed keys with the date of the Order's restoration under Gregory: MDCCCXXXXR, and that of the Pius X renovation, MDCCCCV, impressed in characters of gold upon a blue circle. The ribbon of the decoration is black silk with three narrow red stripes. The star or badge is the cross of the Order attached to a silver star. And for those wanting to know a little about the clobber worn by Knights of St Sylvester, here's the drill: The official uniform is a black coat ornamented with one row of gilt buttons, black velvet, goldembroidered collar and cuffs, black gold-striped trousers, a bicornered cocked silk hat with a cockade of the papal colors. Just the thing when going to the bank, or even picking up a takeaway pizza. Guaranteed pronto fast service!!

Maryvale/Montbel: Job advertisements have recently been placed for a full-time manager's position based at Montbel, which may eventually also incorporate the management of Villa Maria. The provincial has recently met with the Villa Maria and Maryvale/Montbel communities, and with our employees at those communities, signaling the possibility of management changes, and consideration being given to engaging contract services for catering and cleaning at both places. It is expected that job interviews will take place early in November.

Parched Earth: for 3 months Sydney has had no significant rain, combined with some early season hot days. The result is that the Villa Maria grounds are looking increasingly dry and heat stressed. The grass is turning white, and is starting to make a "crunch" sound when walked on. We're hoping for a significant turnaround in the weather before much longer.

Holy Name of Mary Church: Every decade or so the ongoing rising damp problem in Holy Name of Mary church needs attention. So at the moment work is under way on the lower stones of the walls to try and arrest the deleterious effects of the moisture buildup and the corrosive salts which the moisture carries. From time to time weekday Masses will have to be held in the chapter hall adjoining the church, but Sunday Masses, weddings, and funerals will be able to proceed as normal while the work continues.

Royal Commission into Institutional Child Abuse

The Royal Commission is currently operating on a number of levels: it has held a limited number of public hearings; it is conducting private interviews with victims who wish to tell their story of abuse; it has published three "Issues Papers" inviting public submissions on particular topics; it is active in conducting investigations and research; it has issued "Notices to Produce".

So far 6 Catholic dioceses/ archdioceses have been issued with "Notices to Produce": Rockhampton, Brisbane, Wollongong, Bathurst, Bunbury, and Geraldton. These units are required to surrender all documents in their possession relating to institutional child abuse.

Because the Marist Fathers have worked or still are working in the dioceses/archdiocese of Rockhampton, Brisbane, and Wollongong, we have been expecting to receive a parallel "Notice to Produce" in relation to those three areas. Similarly, when and if other Catholic dioceses are served with Notices, we would expect parallel Notices to be served on us if we worked in those dioceses.

It may be, and is probably likely, that individual religious orders will also be served with their own Notices, requesting all the documentation they have in relation to child sexual abuse for all their works throughout Australia.

So far Catholic Church units and agencies have not featured in public hearings of the Royal Commission. However, in December the Royal Commission will hold public hearings in Sydney in relation to the Church's Towards Healing process; and early next year a particular (and so far unnamed) religious order will be the focus of public hearings.

The Catholic Church's Truth, Justice, and Healing Council is acting as a conduit between the Royal Commission and the various Church agencies, dioceses, and religious orders, for the assessment and production of documents. The TJH Council, through its lawyers, Gilbert & Tobin, is reviewing and assessing material held by each Church unit, and as necessary, making that material available to the Royal Commission.

A flyer from the Truth, Justice, and Healing Council is attached with this Provincial Circular. Apologies to Marists who work elsewhere than in Sydney, in that all the quotes in the attached flyer are from Sydney metropolitan bishops. There are variants of the flyers, targeted to various areas of Australia, so that the episcopal statements are adjusted to match wherever the flyers are distributed.

Combined JP event

Marist Justice & Peace groups from Villa Maria parish, the Marist Sisters and the Marist Fathers combined to host an afternoon event at the parish hall on Oct 19.

The afternoon was introduced by **Sr Vivienne Goldstein SM** and parish priest, **Kevin Bates**. Keynote speakers were **Prof Louise Newman** from the Centre for Developmental Psychiatry & Psychology at Monash University, Vic, and **Abdi Aden**, Somalian refugee, arriving in Australia in the 1990s as a youing teenager.

Girls from Monte Sant' Angelo school gave first hand reflections of their 'detention cage' experiences at school, simulating the plight of detained asylum seekers.

The focus of the renewal is to assist men to deepen their conversion and bind them more closely to the mission of the Society. It is aimed at Marists who are about 10 years forward of their final profession, and provincials and district superiors are invited to submit names for consideration.
