Annual Meeting of the Heads of European Education Centres Paris, 30 January - 1 February 2020



This was the fifth meeting of the Heads of Education centres in the province. During these meetings participants discuss themes of common interest, share news and plan collective initiatives. The sixteen education directors who attended this year were joined by three Marist confreres more directly involved in the education ministry.

The European Marist Education Network was established in 2011 to promote collaboration amongst the education centres. The meeting this year took the opportunity to review its purpose and value: Does networking bring major benefits to the education centres or is it just another task that complicates their lives? Is it helpful to build the Network through collective projects or are there simpler ways of doing it?

Participants saw the Network as a way to grow in the understanding of the intentions of the founding generation of Marists and the experiences which gave rise to Fr Colin's insights into education. It allows the education centres to explore collectively their unique Marist character.

Together, they can develop a shared terminology which helps them discuss the common issues they face in different national contexts. Our educational centres are "companions" in a Marist enterprise and through the Network, they can act together more effectively and give flesh to the Marist ethos and characteristic spirit. We still have a contribution to make to the life and mission of the Society of Mary. "There is life until there is death!". A message from lay colleagues at the meeting was that a key development to successfully accomplishing our mission is for us to deliberately integrate them into the Marist spirit, vision and values, "the Marist mind".
