Focus

'Voice' Referendum

The Committee successfully arranged a function on Sep 03 (see cover) in which media presenter and journalist, **Kerry O'Brien**, spoke. One hundred persons, young and old, gathered in the Holy Name of Mary parish hall in a Q&A style session chaired by MLA co-leader, **Cathy Larkin**.

At its final meeting for the year the Committee chose Domestic Violence as the major issue to be addressed in 2024 with an event tentatively scheduled for September.
